Rules for Woodchurch Driving Group RDA 50 Club

The 50 Club draws are licensed under the Gambling Act 2005,
Registration Number LN/0201911084 issued by Ashford Borough Council

1. Membership is open by invitation to members of Woodchurch Driving Group RDA, their family, friends, and those who wish to support our aim: to enable people with disabilities to benefit from carriage driving.
2. Tickets are available at £10.00 each to enter the draws. A ticket number is issued for each entry. Participants may hold more than one ticket.
3. Tickets will be available until 7 days before the draws.
4. The period of membership is for two draws. The draws will take place at our 14 March 2025 AGM and at our September 2025 Fun Day after which reminders will be sent out for the following draws.
5. A full 50% of all ticket sales will directly benefit Woodchurch Driving Group RDA group activities. The remaining proceeds will be divided in to four prizes for each draw – one of 25%, one of 12.5% and two of 6.25%
6. Winners not present when the draw takes place will be notified by email or post, winnings can be paid direct into your bank or sent by cheque.
